IN PORTLAND, OREGON, A PEPSICO FACTORY OF FRITO LAY PRODUCES LARGE AMOUNTS OF SNACKS INCLUDING CHIPS, PRETZELS, DIPS, AND OTHER SNACKS. RLC WORKS WITH THIS FRITO LAY FACTORY AS NEEDED, PICKING UP ON AVERAGE THOUSANDS OF POUNDS OF CASES OF SNACKS THAT WOULD OTHERWISE HAVE BEEN THROWN OUT. RLC DELIVERS THIS TO MANY FOOD BANKS, HOMELESS SHELTERS, AND SOUP KITCHENS AROUND THE PORTLAND AREA. MORE THAN 1,000 PEOPLE BENEFIT FROM THE FOOD DONATED BY FRITO LAY ON EACH DELIVERY. IN 2024, THE PARTNERSHIP CONTINUED TO EXPAND AND RESULTED IN 3,132,000 POUNDS OF FOOD THAT WOULD HAVE BEEN THROWN OUT TO ACCOMPANY MEALS FED TO THOSE IN NEED.
